4. Films must be subtitled in English if language is other than English and Hindi.
5. Films participated in Indian World Film Festival-2017 & 18 are not eligible for participation in 2019
6. Year of production & accepted movie duration:
 - Year of production: Jan-2016 onwards
 - Feature Films/Feature Animation/Feature Documentary: 61 min to 180 min (more than 60 min)
 - Short Film/Short Documentary/Short Animation: up-to 60min
 - Music Video: up-to 7 min
7. IWFF-19 stages/process:
 - Entry submission as per rules & regulations.
 - Notification of shortlisted regular entries by the festival office on 24 Feb 2019 & shortlisted late entries notification on 27 Feb 2019.
 - Delegate registration to attend IWFF-19. All filmmakers must have registered as delegate to attend the festival. Hospitality charges are applicable for filmmakers & attendees, which include lunch, tea/coffee with cookies & master classes.
 - Festival movies screening & workshops followed by award ceremony in Hyderabad on 10 March 2019.
8. The decision of the Jury will be final and can't be challenged.
9. Indian World Film Festival-19 does not take any type financial commitment for the expense incurred on the correspondence by the participant. All Travel, Lodging & Boarding and other miscellaneous expenses will have to be borne by the participant himself for attending the festival. No request for the same will be entertained.
10. Once the film submitted can't be withdrawn in any circumstances, however festival director reserve the rights to disqualify any film on certain grounds.
11. By submitting movie to Indian World Film Festival-19, filmmaker/producer takes the whole responsibility of copyright issues of music, script and other creative and technical aspects of film.
